Abstract Submission: no later than March 15, 2006; Paper Submission: no later than April 30, 2006; Notification for date and time restrictions: no later than May 30, 2006; Hotel block of rooms reserved, at special rate: no later than June 30, 2006.

<u>Session Time Allocations</u>: Most sessions are 120 minutes long (with four presenters); many are 90 minutes long (with three presenters); a few are 140 minutes long (with five presenters.) Each Presenter should take no more than 20 minutes; each Discussant should take no more than 10 minutes; any remaining time should be devoted to questions from the audience.
