Abstracts/papers must not have been published, accepted, or submitted for publication elsewhere. The categories that best fit your paper must be typed on the top right corner of the front page (See below table titled "Subject Category Title and Number"). For co-authorships please include names, affiliations, and addresses of all authors and indicate who will serve as presenter.

Please submit online at www.besiweb.com your papers in Word and PDF. Unless you instruct us otherwise, all papers will pass a double-blind peer review process for publication consideration and selected manuscripts will be published, in printed form, in the semi-annual GLOBAL BUSINESS & ECONOMICS ANTHOLOGY (GBEA) – ISSN 1553-1392. [Format instructions will be attached to the acceptance for publication letter. Manuscripts of more than 12 single-spaced pages of text (font: times, size=10) inclusive of graphs, tables, endnotes and references will be considered at \$10 per additional page].
